Job Purpose:

Provide group and individual instruction to adults who are blind or visually impaired in the use of compensatory skills, all aspects of daily living skills, communication skills, and basic indoor orientation and mobility in order to live safe, productive, and independent lives.

Responsibilities include the following, but are not limited to:

- Conduct assessments, as needed, to evaluate client needs and determine appropriate rehabilitation services
- Develop instructional materials and lesson plans, as needed, to provide relevant, quality services
- Teach weekly or biweekly classes covering areas such as:
 - Activities of Daily Living (including introduction to human guide and indoor protective techniques)
 - Adaptive Kitchen Skills (cooking classes focusing on safety and adaptive tools and techniques)
 - o Communication Skills (including computer keyboarding and braille, when appropriate)
 - Sensory Awareness
 - o Psychosocial adjustment to vision loss
- Prepare reports and complete documentation to track assessments, training, client progress, and follow-up outcomes.
- Access and input client services and progress data into Agency's client management system.
- Collaborate with other professional staff to develop comprehensive client solutions
- Assess client and community needs and recommend appropriate new program developments to supervisor
- Engage in professional development training to stay updated on best practices and industry standards
- Attend meetings and staffings to evaluate client progress
- Attend required Agency meetings and trainings
- Deliver outreach presentations, as assigned, to promote awareness and engagement within the community

Licensure or Certification:

- Certified Vision Rehabilitation Therapist (CVRT) by the Academy for Certification of Vision Rehabilitation & Education Professionals (ACVREP)
- Current Florida Educator Certificate with Visually Impaired endorsement (TVI)
- Ability to obtain one of the above certificates within 6 months of hire

Experience:

 Minimum 1 year of experience working with adults who are blind or visually impaired in a professional setting as a CVRT or TVI

- Instructional Skills Teach adults who are blind or visually impaired, some with multiple disabilities, in group settings and one-on-one
